When to schedule the annual voting membership meeting-

- -We will have the best chance to have dancing before the membership meeting if we have the meeting at the end of October. That way it is more likely for people to sign up as new members before the meeting.

Vote: 7/0/0

-On August 16 Ryan (or someone from the bylaw amendment committee) will present the proposals for the board's review. This should provide enough time to announce the proposed bylaw amendments 60 days before Oct 25.

What weekend shall we choose for the "not really Pigtown Fling"?

- -We need to decide so Tricia can start planning.

- -The last weekend in March 2022 is 25, 26, and 27.
