Review Talent Payment Formula —see \* below — policy of 2/1/16 was put in place as a pilot project to share some of the excess profits with bands (at a time when CCD had a very large balance in accounts.) Suspend the policy because we don't have excess funds at this time? Yes. Reconsider later if warranted.

Bonnie asked for increased payments for callers and bands who come from out of town. We don't have the money to add this, and we seem to have plenty of local callers and bands, so don't really need out of town talent for the dances. No change to rates at this time. They can put out a tip jar (as we've already approved).

Valerie mentioned that a dancer asked why we are charging only \$5 while other groups are charging 10-12 per dance. – tabled discussion.

Deven wanted to discuss "free dance" – currently we have  $2^{nd}$  dance free – go back to policy of having  $1^{st}$  dance free? Why do we even have a free dance policy? Consensus to make first dance free. Caller will announce.
